Dumpster Rental Rules and Regulations

Bulk and Green Waste Dumpsters are available for residential use only.

The following rules and regulations will be strictly enforced:

- Dumpsters are for residential use only! No Business or Commercial contractors are to use this service.
- Toxic, Hazardous or Flammable materials, pesticides, herbicides, solvents, chemicals, paints, motor oil, gasoline, human water, tires, batteries, concrete, rock or asphalt may NOT be deposited in the dumpsters. If there are any of the above-mentioned items in the dumpster, it will be unloaded on site. You will be responsible to clean up the material left behind.
- Dumpsters are not to be overloaded. You will be required, at your expense, to cleanup any spillage if this occurs.
- Be sure to have a responsible adult monitor the dumpster to ensure compliance of these rules as you will be held responsible.
- Any and all fees associated with the dumping of unacceptable material or waste will be the responsibility of the resident and will be added to your utility bill.
- I hereby release Midvale City and Ace Disposal from any and all liability for damages resulting from personnel being on private property to deliver or remove the requested container or from any damages that may arise from any and all liability or injury incurred by individuals from use of said dumpster or damage to the dumpster while on private property.
- I understand that having a container placed in my driveway or at any location I specify or agree to, may cause damage to asphalt, concrete, or any other surface material. Other objective such as sprinkler heads, lines or boxes, water/sewer valve covers or any other object above or below ground at the agreed upon location, may also be damaged during the normal operation of the contracted waste removal service. Damage may be caused by the container. I hereby release Midvale City and Ace Disposal from all liability and accept full responsibility for any damage caused by the container and truck while servicing the container at the agreed upon location.
- The city has no control of drop off and/or pick-up time.

Be mindful that you will be responsible for compliance with rules and regulations as determined by Midvale City and Ace Disposal. Midvale City will inspect dumpster sights after pickup to ensure residential compliance and sight clean up.

3. I hereby release Midvale City and Ace Disposal from any and all liability for damages resulting from personnel being on private property to deliver or remove the requested container or from any damages that may arise from said container. Midvale City and Ace Disposal of Utah are also released from any and liability or injury incurred by individuals from use of said dumpster or damage to the dumpster while on private property.
4. I understand the program is limited to residential use only.
5. I agree to pay all fines and fees that my result with dumping banned materials. Any such amount may be added to my Midvale City utility bill.
6. All court costs and attorney fees incurred in the event of legal action to enforce any terms and conditions of this agreement will be the responsibility of the signee.
